#### 2. Eligibility Criteria:

- Age: All children born between 1<sup>st</sup> July, 2022 to 31<sup>st</sup> December, 2023.
- NO Relaxation will be considered in the date of birth
- The school reserves the right to deny admission to candidates without assigning any reasons.
- All documents are mandatory and have to be submitted to school along with the printed admission form.
- If, residing on Lease, the rent agreement should be valid and registered. (No notarized copies will be accepted)

## 3. Admission Process:

- Priority will be given to Amanora Citizens (owners of residential property) and Siblings of existing students. <u>Cousins are not considered as siblings</u>.
- Amanora Citizens and Siblings should submit the online admission form in their appropriate category and students not belonging to the above category will submit form in the General Category.
- The available seats will be filled as per Lottery System.
- No dues of school fee of sibling.
- Fee Structure is attached. Kindly refer to page no. 5 for details.

## 4. A. Issue and Submission of Forms

Forms will be issued on following dates:

- Online submission link will be closed on Wednesday, 19<sup>th</sup> November, 2025, 5:00 pm. No request for any reason will be accepted for re-issuing of form.

**B. Submission of Documents:** The printed admission form along with all the required documents to be submitted in the school office between 9:00 am to 12:00 noon on Monday, 24<sup>th</sup> November or Tuesdays, 25<sup>th</sup> November, 2025.

C. Result of Lottery: List of Selected candidates will be displayed on the school website on Thursday, 4<sup>th</sup> December, 2025 after 12:00 noon.

# **D.** Confirmation of Admission:

The admission will be confirmed for the selected students:

Friday, 5<sup>th</sup> December, 2025 to Thursday, 11<sup>th</sup> December, 2025 between 9:00 am to 12:00 noon (except Sunday, 7<sup>th</sup> December, 2025).

- vii. Medical Certificate from Registered Medical Practitioner ( M.D. or MBBS) (Form attached)
- viii. Parent Consent Form (Form attached)
- ix. Undertaking from Parent (form attached)
- x. Consent form for APAAR ID. (form attached)
- xi. Copy of Caste Certificate (Notarized True Copy), if applicable
- xii. Copy of Passport / PIO card (for students travelling from outside India),if applicable
- The name on the child's birth certificate and the name on the Aadhar card of the student and parent has to be same. Any mismatch of name on either of the document will not be accepted and the admission will not be granted. Marriage Certificate of parents is not accepted as proof for mismatch of name. Hence kindly ensure the parents name (specifically mother's name) on the birth certificate and Aadhar card is same. For example mother's name on birth certificate is printed that of after marriage name and Aadhar card bears the maiden name or vice-versa, this document will not be accepted and may result in rejection of application.
- The above mentioned documents are mandatory while submitting the documents in school office. The application will be rejected if documents are incomplete. No time extension will be granted for any document.
- In case of Birth certificate in languages other than English / Hindi / Marathi, please bring a notarized copy of the certificate translated in any of the languages mentioned above.

#### 6. Payment of Fees:

#### 7. Allotment of batches:

Nursery section runs in two shifts

Shift-1: 7:50 am to 11:10 am Shift-2: 11:20 am to 2:40 pm

The shifts will be allotted solely at the school's discretion. However, parents can mark their batch preference. Batches once allotted, no request for change in shifts will be entertained. Parents kindly note this before confirming your admission.

## 8. Points to be noted:

- i. Amanora Citizens: Index II copy/letter of allotment etc. needs to be attested by the Amanora office and it is mandatory to be submitted for admission under Amanora Citizens Category.
- ii. The detailed notice for commencement of school will be updated on the school website along with the division / batch details after 20<sup>th</sup> February, 2026.
- iii. Under any circumstances, the fees are always payable to school.
- iv. Fees once paid will not be refunded under any circumstances except the Caution money Deposit.
- v. No relaxation in age, admission date and time and documents will be considered.
- vi. Medical form should be duly attested and signed by a Registered Medical Practitioner (MBBS/M.D.)
- vii. Admission form, Parental Consent, Undertaking form, Medical form, Consent form for Apaar ID and all other documents where signature is required should be duly signed by both the parents and to be submitted .
- viii. Parents are requested not to fill multiple forms. In case the payment is deducted from your bank and the submission of form shows as failed transaction, parents should write an email to <a href="mailto:info@ppspune.com">info@ppspune.com</a> mentioning the child's details and the transaction details. The status of the form will be updated in 3-5 working days and the form will be sent to the email id given.

- 3. Fee Payment Due Dates:
