**Forms open for only Nanded City Residents
(Nanded City Landowners/ Shareholders & Nanded City Resident)**

1. Eligibility Criteria for admission:

Date: 13th March 2026

Std. VI	<p>Based on Activity Test – English and Mathematics of 20 marks each and passed and promoted certificate of the previous Std. from the previous recognized school. Complete LC from previous recognized school is mandatory.</p> <p>Please note that only Nanded City residents form will be entertained. Non Nanded City resident forms will not be considered.</p> <p><u>Seats : 5 Only, Limited Forms are available.</u></p>

- Parents are requested not to waste their time if their ward does not meet the above criterion.

2. Preference for Admission: (*If all dues are cleared of sibling and if seat is available).

Std. VI admissions will be given only on a merit basis.

- Wards of: Landowners/ Shareholders. (***Bonafide certificate from Nanded City is required.**)
- Wards of: Nanded City Flat owners. (***Bonafide certificate from Nanded City is required.**)
- If seats remain, Nanded City tenants. (***Bonafide certificate from Nanded City is required.**)
- If any seats remain vacant, forms may be opened for non–Nanded City residents.

3. Admission Forms for Std. VI

- **Issue of Forms:** Online Forms will be available to **ALL ELIGIBLE** candidates on <https://pawarpublicschool.com/nandedcity/>. The cost of the form is **₹ 2500/- (Non Refundable)**.
- The online Admission Forms for Std. VI will be available from **11:00 a.m. on Saturday, 14th March 2026**. Candidates will have to show the receipt of online payment of admission form fee and **bonafide certificate along with U-DISE+ (PEN) Number & APAAR ID of the student is mandatory** of the previous recognized school to appear for the activity.
- **For Std. VI admissions will be given only on merit basis.**
There will be an activity paper for students seeking admission to Std. VI. The activity paper will be taken for English and Mathematics. Each paper will be of **20 marks**. The activity will be based on the previous Std's syllabus. **Admissions to Std.VI will be based on the performance in the activity and passed and promoted certificate of previous Std. of previous recognized school.**

- An activity paper of **1 hour** will be conducted on **Tuesday, 17th March 2026 or Wednesday, 18th March 2026 at 9:00 a.m.** The **form numbers of selected students (merit list)** will be declared on **23rd March 2026 at 3:00 p.m.** on the **school website and notice board.**
- Only parents of candidates whose names are selected in merit list of activity will be informed by phone call or form number list will be displayed on notice board.
- Admission to Std. VI will be treated as provisional till the receipt of **the Original School Leaving / Transfer Certificate** from the previous recognized school. The last date for submission of the same is **Friday, 24th April, 2026.**

4. Documents to be submitted along with the completely filled and signed printouts of the Selected Online Admission Form (Std. VI):

Admission will be confirmed only after the fees are paid and all documents submitted. You should submit the following list of documents at the time of Admission:

- A self-attested copy of the **Birth Certificate, in English** with the Child's Name, Mother's Name and Father's Name clearly mentioned. **(Mandatory)**
- Four passport size (35mm x 35mm) latest colour photographs of the child properly affixed on the place provided on the printout of the Admission Form and group photo of family (**Mother, Father of child and child**) Size for family photo: **6"x 4" with plain white background. (Mandatory)**
- For Std. II onwards previous recognized School's bonafide certificate along with U-DISE+ (PEN) number and APAAR ID of the student. **(Mandatory)**
- No dues certificate from the previous recognized school. **(Mandatory)**
- The **Original School Leaving/ Transfer Certificate** from the previous recognized school. **(Mandatory)**
- Proof of Residence (Local): A self-attested copy of residence proof. Residence proof should be strictly in the name of the father, mother or grandparents of the child seeking admission **Any ONE** of the following documents can be produced as proof of residence:

a. Passport (Recent)	b. Electricity Bill (Recent)
c. Registered Sale / Rent Agreement Copy (Recent)	d. Aadhaar Card
e. Bank statement for the current month	f. Telephone Bill (Land Line)
- For Std. VI a self-attested copy of the mark sheet of the previous Std. from the previous recognized school. **In case of student migrating from other countries, Indian Embassy stamp is mandatory on Transfer Certificate.**
- The **Medical Certificate** provided in the printout of online Admission Form has to be completely filled, signed and stamped by a **Registered Medical Practitioner. (Mandatory)**
- Photocopy of Passport / OCI card (for students migrating from outside India). **(Mandatory)**
- Parents from the Reserved Category, who want the caste to be entered in the school register should submit a self-attested copy of the **Caste Certificate in the name of the student / father issued by the concerned Government Authorities at the time of admission.**
- A self-attested copy of the **student's aadhaar card and both the parents' aadhaar card** is mandatory. **(Mandatory)**
- Admission to Std. II to Std. VIII will be treated as provisional till the receipt of the original School Leaving / Transfer Certificate from the previous recognized school. The last date for submission of the same is **Friday, 24th April, 2026. (Mandatory)**

➤ **You are requested to carry all the original documents for verification.**

5. Payment of Fees for new Students of Std. VI :

- Fees will not be accepted without submission of all the required documents.
- Details of Fee Structure for the academic year 2026-27 are displayed on the school notice board and attached with notice.
- Fees have to be paid through a **Demand Draft or UPI only** in the administration office of the school at the time of submission of the printouts of the admission form and the other documents.

At the time of admission two separate **Demand Draft or UPI only** have to be submitted in favour of "**Pawar Public School, Nanded City**" as follows:

- 1) "**Pawar Public School, Nanded City**" for **₹ 65,000/- (Interest Free)** towards Refundable Caution Money Deposit,
And
- 2) **Full Annual fees for Std. VI ₹ 76,652/-** (Admission Fees, 1st quarter, 2nd quarter, 3rd quarter, 4th quarter) will have to be paid at time of admission.
- 3) PTA fees: Fees have to be paid through Cash / Cheque in favour of "**PPS Nanded City – PTA Account**" for **₹ 50/-** towards Parent Teacher Association.
- 4) Students taking admission in any month after April 2026 have to pay the fees from month of admission.

6. Cancellation of Admission:

- 1) Those parents who wish to cancel the admission of their ward should give a written application signed by both the parents/ guardians who signed the admission form, seeking cancellation of admission.
- 2) Only the **Caution Money Deposit (Interest Free) & ONLY 2nd quarter onwards fees** will be refunded to those who seek cancellation of admission before 31st May 2026.
- 3) The application for withdrawal has to be accompanied by an application for the refund of caution money along with the original caution money receipt stating the name in which the refund cheque has to be issued. The caution money deposit amount will be refunded to the applicant **after 21 working days**, from the receipt of the application.
